Vendors must secure knives, swords, or any other weapons from public access and must be cleared with TMMRMF. NO FIREARM SALES.

Spaces will be pre-assigned. TMMRMF will not guarantee specific locations.

The playing of ambient music must be confined to the vendor rental space.

Vendor merchandise infringing on copyrights shall be removed from the event, unless preapproved.

Vendor space subletting without written permission from TMMRMF is not permitted.

Vendors may not place stakes in the asphalt! No Dumping of gray water, food, or anything else is allowed on the property or streets.

The Town of Taos and the State of New Mexico require event Sales Tax License.

Sales tax is 8.625%. Please go to <https://tap.state.nm.us/> to obtain the form you need.

Food vendors are required by the State of New Mexico to have a Food Establishment License.

must be displayed where they are visible! Propane users will be inspected and licenced prior to opening.

Town of Taos will inspect all Tattoo Vendors. Please comply with state regulations.

There will NOT be any tent or RV camping in vendor area!

Vendor setup will begin at 3P.M. and end at 8P.M. on July 9th, 8am to 10:00 am July 10th.

Vendors must supply their own tent, canopy, tables, chairs, etc. You may contact Garcia Tents in Albuquerque NM 505-842-8368 if you wish to rent these items.

All vendor booths MUST be in place by July 10th 11:00 am. TMMRMF will provide a marked space.

Hours of operation are Friday July 10 to Sunday, July 12. Vendor hours are from 12 P.M. each day, and until end of show. No teardown before **7:00 P.M.** Sunday July 12th. All vendors MUST be off the event site

by Monday, July 13th by 12 pm

Vendor Safety

All vendors will obey all pertinent fire and safety codes, laws, and ordinances and regulations as mandated by the Town of Taos, State of New Mexico, and TMMRMF. Per fire safety codes, canopies provided by vendors must be fire retardant.
